5. Buyer's Representations

The Buyer represents and warrants that:

- (a) The Buyer is at least 18 years of age for long guns, or at least 21 years of age for handguns;
- (b) The Buyer is legally permitted to purchase, own, and possess a firearm under applicable federal, state, and local laws; and
- (c) The Buyer is not prohibited under 18 U.S.C. § 922(g) or any applicable Georgia law from receiving or possessing a firearm.

6. Transfer of Ownership

Upon receipt of full payment, all right, title, and interest in each firearm described herein shall transfer from the Seller to the Buyer. From the date of this Agreement forward, the Buyer assumes all responsibility for the safe storage, use, and lawful possession of the firearm(s).

7. As-Is Sale

Unless otherwise expressly stated herein, the firearms are sold "AS IS." The Seller makes no additional warranties, express or implied, beyond those stated in Section 4 above.

8. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the State of Georgia, without regard to its conflict of law provisions.

9. Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the sale of the firearm(s) described herein and supersedes all prior discussions, representations, and agreements, whether written or oral.
