THE SELLER MAKES NO OTHER REPRESENTATION OR WARRANTY, EXPRESS OR IMPLIED, WITH RESPECT TO **THE FIREARM** OR ITS CONDITION.

THE SELLER ACKNOWLEDGES TO BE THE LEGAL OWNER OF **THE FIREARM** LISTED. THE SELLER AGREES TO REFUND THE BUYER THE FULL PURCHASE PRICE IF IT CAN BE SHOWN NOW OR IN THE FUTURE THAT THE FIREARM WAS STOLEN BEFORE THE DATE LISTED ON THIS FORM. THE SELLER SELLS AND DELIVERS **THE FIREARM** TO THE BUYER, AND THE BUYER ACCEPTS **THE FIREARM**, "AS IS".

The Buyer acknowledges that he/she is not prohibited from possessing a firearm by law under 18 U.S.C. § 922(g) or the Texas Penal Code, and that he/she is at least 18 years of age (long guns) or 21 years of age (handguns) as required under Texas and federal law. The Buyer warrants to the Seller that the Buyer has thoroughly examined **the Firearm**, that the Buyer is purchasing solely in reliance upon such examination and testing, and that the Buyer is fully satisfied with **the Firearm** "AS IS".

The Seller shall incur no obligation or liability whatsoever for or on account of any condition existing in **the Firearm** following the transfer of ownership to the Buyer.

**LAWDISTRICT**

This bill of sale will be governed by the laws of the **State of Texas**, including applicable provisions of the Texas Penal Code (Title 10) and federal law, including the Gun Control Act of 1968 (18 U.S.C. § 921 et seq.).
